SUSPECT DISPOSITION:		
Carr was arrested on Friday, March 1, 2024, arraigned in court the following week, and subsequently released with Conditions of Release.		

In February of 2024 the Chittenden Unit for Special Investigations (CUSI) was referred a case from the Vermont Department for Children & Families (DCF) regarding potential sexual and physical abuse of an 8-year-old juvenile.

The case was accepted by CUSI for further investigation in conjunction with DCF. That investigation subsequently resulted in the development of probable cause to believe that David Carr, 36, then of South Burlington, committed the crimes of Lewd or Lascivious Conduct with a Child and Simple Assault on that juvenile victim.

On the afternoon of Friday, March 1, 2024, Investigators from CUSI arrested David Carr at 1016 Shelburne Rd in South Burlington, VT without incident. Carr was subsequently processed and lodged at Northwest Correctional Facility on bail set by a Superior Court Judge.

On Wednesday, March 6, 2024, David Carr was arraigned in court and released back into the community by a Superior Court Judge with Conditions of Release.

David Carr's criminal history includes pending matters in Vermont and prior felony convictions from another state.

Lewd or Lascivious Conduct with a Child in violation of Title 13 V.S.A. § 2602(b)(1)- A person who commits the crime of Lewd or Lascivious Conduct with a Child for their first offense shall be imprisoned for not less than 2 years with a maximum term of 15 years, and, in addition, may be fined not more than \$5,000.00.
