Thank you for this reminder Mary, I am aware of it and in fact, on behalf of my client, I need to request that the DRB postpone the hearing set for October 16 as it relates to 14/16 Peru Street and reschedule it for a date some time in November or December. As you know, at the last hearing, our matter was suspended and continued to allow us to reformulate our approach to solving the problems my client faces. Pursuing PRD/PUD options is our plan and we are simply encountering delays in shifting to this approach. We have met with my client's engineers and planners who are assisting us with this project and we simply need more time to finalize what we expect to present to the DRB.

Accordingly, we would ask that the hearing be rescheduled in order to allow us to properly and adequately prepare and present the DRB with a thorough and complete proposal under the CDO. I apologize for this delay but ask that the DRB allow for this requested continuance in order for my client to fully examine its best options and present what it hopes will be acceptable to the DRB.
