Mr. Carner was held without bail pending a hearing TBD by the court.		

On Oct 12, 2018 the Chittenden Unit for Special Investigations (CUSI) was contacted by the Department of Children and Families (DCF) regarding a report that Mr. Nathaniel Carner, 25 of Milton, VT had sexual abused a known juvenile under the age of 13. Detectives from CUSI along with Family Services Works from DCF began investigating the allegation.

On Oct 23, 2018 Detectives from CUSI interviewed Mr. Nathaniel Carner. After the interview, Mr. Carner was subsequently arrested for the crime of aggravated sexual assault. Mr. Carner was arraigned this afternoon in Chittenden County Criminal Court and held without bail.

Aggravated sexual assault, Title 13 V.S.A. § 3253 (A,8)-A person commits the crime of aggravated sexual assault if the person commits sexual assault under any one of the following circumstance; (8) The victim is under the age of 13 and the actor is at least 18 years of age. A person who commits the crime of aggravated sexual assault shall be imprisoned not less than ten years and a maximum term of life, and, in addition, may be fined not more than \$50,000.00.

If you or someone you know has been a victim of sexual assault, there is support available. Even if the assault did not happen recently, there are resources to help you decide what is best for you, including free medical treatment, advocacy and support.
