SEX OFFENDER RELEASE NOTIFICATION

March 25th, 2020



DARRYL M. GALLOWAY (56 y/o)

Descriptors: 5'7"/ 190 pounds

Black hair/Brown eyes

On March 25th, 2020, Mr. Darryl Galloway will be released from custody of the Vermont Department of Corrections and will be under the supervision of Burlington Probation and Parole. Most recently, Mr. Galloway has served a term of incarceration related to several lewd and lascivious conduct convictions in 2007. At this time, it is anticipated that Mr. Galloway will be homeless upon his release.

Officials with the Vermont Department of Corrections indicate Mr. Galloway is currently engaged in sex offender treatment. However, he has a history of non-compliance with DOC supervision. Additionally, Mr. Galloway will be listed on the Vermont Sex Offender Registry. Mr. Galloway's risk to commit another sexual offense is considered to be in the "High Range". According to the Vermont Department of Corrections, if Mr. Galloway were to sexually re-offend, his most likely victims would be teenage to college age females both known and unknown to Mr. Galloway.

Reference his most recent conviction, Mr. Galloway entered a clothing store on Church Street in Burlington. He then removed his pants and underwear to try on new pants. This act exposed his genitals to the female staff on duty. When the staff confronted him, he did not cover up. He eventually left the store peacefully. When the staff reported this incident other victims of similar behaviors came forward. Mr. Galloway has a prior conviction for public masturbation in front of college age females near the UVM campus. Mr. Galloway also has convictions for aggravated stalking of a college age female in the Burlington area as well as attempted sexual assault for trying to force a female to have sex with him.

If you or someone you know has been a victim of sexual assault, there is support available. Even if the assault did not happen recently, there are resources to help you decide what is best for you, including free medical treatment, advocacy and support.
