SUSPECT DISPOSITION:		
Alen Lendo was taken into custody and charged with Unlawful Trespass into Occupied Dwelling (Felony) in accordance to Title 13 VSA 3705. Lendo was transported to Chittenden County Superior Courthouse to be arraigned on the mentioned charged. Lendo was arraigned and released on the above charge with court conditions. Lendo however was held on a mittimus warrant for failure to appear on unrelated charges and transported to Northwest Correctional Facility.		

**NARRATIVE:**

On August 3, 2021 at approximately 0834 hours, Burlington Police Dispatch Center received a 911 call that an unknown male was inside the bathroom in a neighboring apartment. Dispatch advised Officers the unknown male was not responding to the caller.

Officers arrived on scene and spoke to the caller and the tenant of the apartment in question. The female advised Officers that she momentarily left her apartment to bring her cell phone to her son. The female returned a few minutes later to hear music coming from the bathroom. The female observed an unknown male sitting fully clothed on the toilet. The female quickly exited her apartment and ran to her son's apartment next door.

Officers entered the residence and located a male fully clothed, sleeping while he sat on the toilet. Officers were able to wake the male and immediately recognized him as Alen Lendo, age 41 who is well known to Law Enforcement.

Lendo's criminal history includes 8 Failures to appear, 24 Violation of Court Orders or Conditions charges (3 Convictions), 12 Felony charges (1 Conviction), 53 Misdemeanor charges (13 Convictions), 1 Unknown Offenses (0 Convictions), 9 Assaultive Crime charges (5 Convictions), 1 Assault on Officer charge, 2 Dangerous/Deadly Weapons charges, and 2 Violation of Probation/Parole charges.
