SUSPECT DISPOSITION:		
Tyshawn Lee was taken into custody today for 1 st Degree Aggravated Assault, 1 st Degree Aggravated Domestic Assault with Weapon (2 counts), and Domestic Assault (2 counts). Mr. Lee was lodged at Northwest Correctional Facility on \$25,000.00 bail and conditions to only be released to a responsible adult. Mr. Lee will be in court on Monday, November 15, 2021 at 1030 hours to answer to the above mentioned criminal charges.		

NARRATIVE:

On November 12, 2021 at approximately 0922 hours, the Burlington Police Department responded to the area of 93 So Winooski Avenue for a third party report of a male kicking a female in the parking lot.

Officers arrived on scene, interviewed witnesses, and collected video evidence in the area. The preliminary investigation identified the attacker as the victim's boyfriend, Tyshawn Lee, age 20. The investigation indicated the victim was pulled by her hair to the ground, kicked in the stomach, and had her head forcibly struck multiple times against the ground by Lee. Lee forcibly held the victim down as he assaulted her. The victim revealed that earlier in the day Lee held a firearm to her head while they were inside Lee's vehicle. The victim was transported to UVMHC's Emergency Department to be treated for her injuries.

On November 13, 2021, Burlington Police Department located Lee's vehicle parked at Leddy Park near the hockey rink. Lee was taken into custody without incident. Lee's vehicle was seized pending a search warrant granted by the Courts.

Lee will appear in court on November 15, 2021 at 1030 hours to answer to 1st Degree Aggravated Assault, 1st Degree Aggravated Domestic Assault with Weapon (2 counts), and Domestic Assault (2 counts).
