SUSPECT DISPOSITION:		
Charles Noss was arrested and charged with Burglary to occupied dwelling. Noss was lodged at Northwest Correctional Facility on \$5,000 bail.		

NARRATIVE:

On November 23, 2021 at approximately 2239 hours, Burlington Police Department received a 911 call of a burglary in progress. The caller stated they could hear yelling coming from downstairs and what sounded like glass breaking. The residents of the home hide and secure themselves in the upstairs bathroom.

Officers arrived on scene and made entry into the house. As Officer searched the house they found a male inside the living room. The male was identified as Charles Noss, age 38. Noss is known to law enforcement from previous encounters. Noss was taken into custody and transported to the Burlington Police Department.

Preliminary investigation revealed that Noss entered the home and caused up to \$10,000 in property damage. Noss made statements that the building was easy to “infiltrate”.

Noss’ criminal history revealed 1 failure to appear for court proceedings, 2 misdemeanors convictions, 1 assaultive crime charge, and two violation of probation and parole.

Noss is currently on court conditions from a previous burglary that occurred back in September 2021. Additionally, Noss was arrested for Burglary and violation of court conditions on November 6, 2021 and lodged at Northwest Correctional Facility. On November 19, 2021, Noss was arrested again and charged with Burglary, Arson, and Violation of Court Conditions. Noss was lodged at Northwest Correctional Facility.

Noss has had 57 Law Enforcement contacts since January 2020 to November 2021.

Noss was lodged at Northwest Correctional Facility for the current arrest and held on \$5,000 bail. Noss is scheduled to appear in Chittenden County Superior Court on November 24, 2021 at 1030 hours to answer to the new charge of Burglary into an occupied dwelling.
