Chapple has been charged with DUI, Leaving the Scene of an Accident, Aggravated Assault, and Simple Assault On A Law Enforcement Officer. Chapple has been lodged at Northwest State Correctional Facility and is ordered to court on June 12, 2023 at 9:30am.		

NARRATIVE:

On June 11, 2023, at approximately 1:09am, the Burlington Police Department received a report of a vehicle that backed into another vehicle and left the scene of the accident. The complainant identified both the vehicle and its operator to an officer.

Around 1:54am officers located the vehicle with open alcoholic beverages and the suspect inside. The suspect was later identified as Dylan Chapple, 27, of Swanton. While speaking with Chapple, officers observed several indicators of impairment. Chapple was taken into custody for suspicion of Driving Under the Influence (DUI) and transported to the BPD. During transportation, Chapple began yelling at and threatening officers. On arrival at the BPD, Chapple became increasingly aggressive and attempted to kick an officer. Chapple was restrained and taken to the ground. One officer was bitten on the arm, breaking skin and drawing blood, and another officer was kicked. The Burlington Fire Department arrived to take Chapple to the University of Vermont Medical Center for evaluation when he complained of mouth pain.

Chapple has been charged with DUI, Leaving the Scene of an Accident, Aggravated Assault, and Simple Assault On A Law Enforcement Officer. Chapple has been lodged at Northwest State Correctional Facility and is ordered to court on June 12, 2023 at 9:30am.
