Joshua Garvey was lodged at Northwest State Correctional Facility. Travis Landry was taken into custody.		

NARRATIVE:

On September 13, at approximately 10:19pm, officers from the Burlington Police Department responded to a report of disturbance. Upon arrival, officers recognized one of the individuals to be Travis Landry, 34, of Lyndon from previous law enforcement contacts. Officers had prior knowledge that Landry was wanted in an active criminal investigation regarding a stolen vehicle. Landry was taken into custody without incident for Aggravated Operating without Owner's Consent, felony.

During the arrest of Landry, a male began to approach officers. The male was later identified as Joshua Garvey. Officers advised Garvey to stop walking towards them and to keep a safe distance. Garvey ignored the officers' commands and continued to approach the officers who were conducting a search incident to arrest on Landry. Officers warned Garvey that if he did not stop he would be placed under arrest for impeding an officer. Garvey did not comply and began interfering with the arrest of Landry. Officers had to expedite the search on Landry due to safety with Garvey ignoring commands to stay away.

Once Landry was placed into a police cruiser, officers advised Garvey he was under arrest. Garvey resisted and a struggle ensued. Additional officers responded to the scene, oleoresin

capsicum (OC spray) was deployed. Garvey was placed into handcuffs and transported to the BPD for decontamination and processing without further incident. Two officers received injuries from the altercation.

Garvey was lodged at Northwest State Correctional Facility on a \$1,000 bail.

Garvey's criminal history includes 4 failures to appear, 5 violation of court orders or conditions charges, 5 felony charges, 2 felony convictions, 29 misdemeanor charges, 17 misdemeanor convictions, 12 assaultive crime charges, 10 assaultive crime convictions, 1 escape charge, 9 violation of probation/parole charges, and 5 violation of probation/parole convictions.
