Synopsis

Caller on 911 stated to the effect they observed two males fighting then they both ran away. A second caller stated to the effect they found blood on a door and on the ground near where the males were fighting. Officers arrived, located two suspects, one suspect that had blood on him. As the officers spoke with him, he became upset with them investigating the incident. As they spoke with this suspect, the second suspect walked up and attempted to re-engage the first suspect. Another officer arrived on scene and attempted to speak with the first suspect but the suspect continued to be belligerent and postured up to the officer. The officer stated to the effect to the suspect that they were going to be detained in handcuffs. A second officer moved behind the suspect and took hold of their arms and attempted bring them behind his back. The suspect actively resisted the officer, pulling away from him and the officer began to transition



the suspect to the ground. The suspect then complied; the officer kept the suspect standing and placed them into handcuffs.

The female then resisted the officer's attempts to stand her up. A third officer assisted in physically lifting her onto her feet and held her while the first officer placed her into handcuffs. The female physically resisted walking over to the police cruiser and officers had to physically move her to the cruiser. Once at the cruiser the female refused to get in and an officer physically pulled her into the cruiser. The female was then transported to UVMMC ED on the EE warrant.

Synopsis

An officer was speaking consensually with the operator of a motor vehicle he had just observed a female, whom they recognized from previous law enforcement contact, go up to the window of said vehicle and then depart. The officer checked with dispatch for warrants for the female and that revealed an active warrant for her arrest and conditions of release from court with a curfew that she was also currently violating. The officer stated to the effect to the female that she had a warrant and was under arrest. The officer allowed the arrestee to hand over her possessions to a friend and smoke a cigarette. The arrestee began to stretch out the time that was given them and then began to state to the effect that she was going to do what she wanted. A second officer had arrived on scene by this time. The first officer took control of the arrestee's arms and placed her into handcuffs. As the first officer searched the arrestee, the second officer had to hold onto her right arm. The arrestee began to squirm and pull away from the second officer causing the officer to have to physically hold her in place. After being searched, the first officer opened the door to the back of the cruiser. The arrestee immediately dropped her weight and the second officer had to physically pick her back and order her into the vehicle. The arrestee refused to get in and pushed her body weight back against the second officer. The officer had to physically move the arrestee into the vehicle. Once seated in the vehicle with the arrestee's legs were still out of the cruiser and she refused to move them in. The second officer had to physically move both legs into the back of the cruiser.

The officer had sent out a name and picture of the suspect to BPD personnel. An officer on patrol observed the suspect on a bicycle and went out with him. The officer stated to the effect for the suspect to stop riding the bicycle but the suspect continued to ride away from the officer. A second officer stopped their cruiser on the street ahead of the suspect and the suspect then stopped. The first officer arrived, as did the investigating officer. The second officer left the scene. The investigating officer stated to the effect that the suspect was under arrest, to turn around and place his hands behind his back. The officer took hold of the arrestee's right arm and attempted to guide it behind the arrestee's back. The first officer took hold of the arrestee's left arm and attempted to do the same. The arrestee actively resisted by pulling his arms away and twisting. The arrestee managed to break the first offices hold. The first officer was able to re-establish the hold on the arrestees left arm and move it behind the arrestee's back. The investigating officer was able to physically move the arrestee's right arm behind the arrestees back and attempted to place handcuffs on. A third officer arrived and was able to complete the handcuffing of the arrestee.

Synopsis

BFD called BPD to respond to male subject they were dealing with who was now becoming combative. BFD stated the male had left the area. BFD called back shortly stating the male had assaulted BFD personnel, spitting on them and threatening to punch them. Officers arrived on scene and began to canvass the area for the male subject, who is well known to emergency services. An officer located the male suspect on a nearby street. The officer went out with the suspect and engaged in a dialogue with him until a second officer arrived on scene. At this point, the officer stated to the effect to the male that he was under arrest. The officer took hold of the arrestee's right arm and attempted to move it behind the arrestee's back. The arrestee began to actively resist, pulling his arm forward. The officer had to physically hold the subjects arm behind his back. The second officer took hold of the arrestee's left arm and move it behind the arrestee's back. The arrestee actively resisted, stiffening his arm and attempting to pull it forward. The officer had to physically hold the arrestee's arm behind his back and apply handcuffs. As the officers moved the arrestee towards the cruiser, the arrestee continued to actively resist, trying to pull his arms out of the officers grasp. At the cruiser, the arrestee was being searched, the arrestee continued to resist, pushing his body up and away from the cruiser. The arrestee spat at the officer conducting the search. The arrestee's saliva struck the officer landing in the officer's mouth. The arrestee was brought to the ground in a controlled manner to finish the search. A third officer had to hold the arrestee's legs while the search was being completed. The arrestee was then stood back up and placed into a cruiser.

Synopsis

An officer patrolling the parking lot at the Fletcher Free Library in the early hours of the morning observed a motor vehicle parked and idling, occupied by four subjects. The officer observed the four subjects hastily exit the vehicle and begin to walk away from the officer. Believing the vehicle might be stolen the officer specifically called out for the operator to stop. The male subject ran from the officer. The officer pursued the male, while stating to the effect to the male to stop and identifying himself as a Burlington Police Officer. The officer stated to the effect over his radio he was in a foot pursuit. After approximately 40 seconds, the officer caught up to the male as a BPD police cruiser had pulled up in the path of the male's flight causing them to slow down. The officer attempted bring the male to the ground but the size of the male prevented the lone officer from doing this. The officer attempted to gain control of one of the male's arms but the male pulled his arm to his chest preventing the officer from gaining control of his arm. The male began to fight with the officer as the second officer who exited their cruiser arrived. The second officer initially attempted to gain control of the male's right arm but he pulled it away. The second officer then took hold of the male's legs and the two officers were able to bring the male to the ground. The second officer took hold of the male's right arm and the male brought it up to his face. The second officer had to pull the male's right arm down and behind the males back. The male fought back trying to pull his arm forward. A third officer arrived and began to assist the first officer in placing the male into handcuffs. A fourth officer arrived on scene and took control of the males left arm. The second officer transitioned to the males left leg and physically pinned the leg to the ground. The first officer applied OC to their gloved hand and swiped in onto the male's face to try to gain compliance. The third officer took hold of the male's right arm and applied a handcuff. The fourth officer applied a separate handcuff. Then the two sets of handcuffs were daisy-chained together. The officers then tried to escort the arrestee to the cruiser but the arrestee refused to walk. The four officers had to physically carry the arrestee to the cruiser and set them on the ground. While seated on the ground the arrestee attempted to pass the handcuffs under his body to move his hands in front. The arrestee was placed in a prone position and the fifth officer took control of one of the arrestee's legs while a sixth officer took control of the other leg. The daisy-chained handcuffs was removed and one set of handcuffs was applied. Officers learned the arrestee had an active warrant and was currently on parole. The first officer had



injuries to his hand and ankles. The arrestee stated had jaw, back and finger pain. BFD was called to the scene and ultimately transported the arrestee to UVMMC ED for evaluation. The arrestee was evaluated, cleared and transported to BPD.

The officer did not want the operator to flee the scene if they came to. The officer first took hold of the male as the officer stated to the effect to the male that they were Burlington Police. The officer felt the male tense up as the officer reached over him and turned off the vehicle. The officer then stated to the effect to the male to exit the vehicle. The male did not comply and the officer physically removed the male from the vehicle and brought him to the ground in a controlled manner. A second officer who had been on the other side of the car came around to assist the first officer taking hold of the male's left hand to remove him from the vehicle then taking hold of the male's right arm and guiding him to the ground. The first officer brought the male's right hand behind his back, the second officer brought the male' right arm, and hand



behind the males back and applied handcuffs. Officers were informed by dispatch the male had an active warrant for his arrest.

The name and date of birth were valid but the descriptors and DMV photo obtained by the officer was not of the female in front of them. The officer then spent approximately 11 minutes attempting to use other means of corroborating her original stated identification, to include phone numbers, know associates and social security number. During this time, a third officer arrived on scene. The female could not provide any of this information. The officer explained the false information to a police officer statute and explained that if she had a warrant for her arrest that it could be safely and easily resolved without any new charges. The female continued to state that she was the person whose name she had given. A male subject arrived on scene whom the officer recognized from previous law enforcement encounters. The female explained to the male that the officer did not believe she was the female she stated to be and that the male had her information in a bag with him. When the first officer was speaking with the male, the female picked up her bike and attempted to ride away. The first officer and the third officer each took hold of one of the female's arms to prevent her from leaving. The female continued to actively resist and the officer brought her to the ground in a controlled manner. Once on the ground the two officer were able to place the still resisting female into handcuffs. At the same time, this was occurring; the male pushed by the officer with him with his fists balled up and went towards the two officers and the female. The officer stepped in front of the male to prevent him from doing so by pushing the male back. The male again tried to push past the officer and the officer brought the male to the ground in a controlled manner. An officer left the female and assisted the officer with the male on the ground. The third officer was able to place the male into handcuffs.
